- The Language Practitioner will also transcribe (English /Sepedi) work assigned to him/her.
- The Language Practitioner will also provide subtitles to audio or video recorded sessions (e.g. lecturer, presentation, VC's speech, etc.) as and when required.
- The Language Practitioner will design, develop, and facilitate the high-quality Sepedi modules for the communication.
